This juried exhibition is open to all artists using photographic processes: analog or digital, color or B&W, alternative processes and mixed media explorations. **Contemporary Photography in Hawai'i 2017** is meant to offer artists who use photography a venue for exhibiting work and to provide a snapshot of the "state of the art" of contemporary photography in Hawai'i.

Hawai'i residents, amateurs and professionals, are welcome to submit images.

### REQUIREMENTS

- Images must have been created within the past two years and not previously exhibited in Hawai'i.
- Open to photographers living in the state of Hawai'i.
- Work must be original.
- Selected work must be printed for the exhibition.
- Frames and mattes: You will need to provide your own framing for the exhibition.

Frames up to 24" X 30" will be accepted.

We recommend simple, unobtrusive matting (white or off-white matts) and simple metal or wood frames (black, white, or gray) for consistency in the exhibition.

Framing available at Art Source and Designs/Diane Ko for 25% off any custom or standard exhibition frame. Please make arrangements at least 10 business days before the due date.
